ABBREVIATIONS TO BE USED IN COLUMNS INDICATED: Col. 1-Indicate the home-maker in each family by the letter 'H', following the word which shows the relationship, as 'Wife-H' or 'Head'. Col. 2-Indicate the sex of the person by the letter 'M' for male and 'F' for female. Col. 3-Indicate the race of the person by the letter 'W' for white, 'N' for negro, 'O' for other races, spell out in full. Col. 4-Indicate the color of the person by the letter 'W' for white, 'N' for negro, 'O' for other colors, spell out in full. Col. 5-Indicate the age of the person at last birthday. Col. 6-Indicate the marital condition of the person by the letter 'M' for married, 'S' for single, 'W' for widowed, 'D' for divorced. Col. 7-Indicate the educational attainment of the person by the letter 'A' for attended school, 'C' for college, 'H' for high school, 'U' for university, 'P' for postgraduate, 'N' for none. Col. 8-Indicate whether the person is literate and writes by the letter 'Y' for yes, 'N' for no. Col. 9-Indicate the place of birth of the person by the name of the State or Territory, or of the foreign country in which birthplace is now situated. Col. 10-Indicate the place of birth of the father of the person. Col. 11-Indicate the place of birth of the mother of the person. Col. 12-Indicate the mother tongue of the person by the name of the language spoken in the home before coming to the United States. Col. 13-Indicate the country of birth of the mother tongue. Col. 14-Indicate the year of immigration to the United States. Col. 15-Indicate the date of naturalization. Col. 16-Indicate whether the person is a citizen of the United States by the letter 'Y' for yes, 'N' for no. Col. 17-Indicate the occupation and industry of the person by the name of the occupation and industry. Col. 18-Indicate the code of the occupation and industry. Col. 19-Indicate whether the person is actually at work on the last regular working day by the letter 'Y' for yes, 'N' for no. Col. 20-Indicate whether the person is a veteran of the U.S. military or naval forces by the letter 'Y' for yes, 'N' for no. Col. 21-Indicate the number of years of service in the military or naval forces. Col. 22-Indicate the number of years of service in the military or naval forces.
